CDBG CERTIFICATION OF COOPERATION AGREEMENT

Mayor Sadara B. Barrow gave information on CDBG. It is a requirement of Prince George's County to have CDBG Grant Certification in order to apply for and receive grant funding. Discussion was held on CDBG services.

Mayor Sadara B. Barrow called for a motion to agree to the terms and execution of the Cooperation Agreement.

Motion made by Council Member Blue to agree with terms and execution of the Cooperation Agreement. Seconded by Council Member Epps. The motion was passed with a vote of 5-0.

PTYC- SUMMER STUDENT WORKER

Discussion took place regarding the ETHM and Colmar Manor's Summer Employment Programs. It was agreed that funding would remain the same for this year with the town only paying for the four town youths. This will be considered further during next year's budget.

Mayor Sadara B. Barrow called for a motion to change the name of the account to Summer Employment.

Motion made by Council Member Jackson to change the account name from “Port Towns Job for Youth” to “Summer Employment”. Seconded by Council Member Epps. The motion was passed with a vote of 5-0.

PTYC – SENIOR VAN USAGE

Discussion was held on PTYC using the Senior Van to transport children from Bladensburg High School to Greenbelt Middle School and William Wirt Middle School.

Mayor Sadara B. Barrow called for a motion to allow ETHM use of the bus. The times were discussed along with bringing on an additional driver.

Motion made by Council Member Jackson to allow ETHM to use the bus if it was available and if driver is available on the following dates 7/1-7/3/14 and 7/15-7/17/14 at the cost of \$25/hour.

Rev. Addison joined the meeting and after further discussion the following motion was made.

Motion made by Council Member Jackson to allow ETHM to use the bus on 7/15-7/17/14 if the bus and driver was available at a cost of \$12.50/hr. Seconded by Council Member Epps. Motion was passed with a vote of 5-0.

Mayor Sadara B. Barrow called for a motion to go into an Executive Closed Session at 7:12 p.m. to consult with Legal Consul.

Motion made by Council Member Epps to go into an Executive Closed Session to consult with Legal Counsel. Seconded by Council Member Bowden. Motion was passed with a vote of 5-0.
