Sgt Cowling and Officer Merritt recently joined the Colmar Manor Police Department. We are providing increased police patrols of our residential and business areas. Between the COVID-19 health emergency and reduced staffing, our enforcement of town ordinances has been limited – we have now resumed enforcement. We are currently issuing warnings for parking permit violations but will soon begin issuing citations. Please ensure that your vehicle(s) are properly registered and display a residential parking permit. Parking permits are available at Town Hall. MVA is now open by appointment only for your drivers license and vehicle registration needs.

# CODE COMPLIANCE MONTHLY REPORT

*THE FOLLOWING REFLECT THE ACTIVITY OF THE CODE COMPLIANCE OFFICE FOR  
THE MONTH OF JUNE 2020*

Follow-up from May: seven properties that were issued high grass and bulk trash notices were found to be in compliance.

Eleven high grass warning notices were issued in June as well as one for the open storage of wood and trash.

Code Enforcement has also been working to identify residences placing their recyclables curbside in plastic bags. Plastic bags inhibit the processing of the recyclables and are prohibited. Town Ordinance O-4-2019 prohibits plastic bags as part of recycling whether inside or outside the recycling bin and provides for a \$50 fine for violation of the ordinance. 39 warning notices were issued during the month; a recent inspection determined that the situation has improved.

## Waste Collection Days

<b>Monday</b>	Household Trash	Regular Trash is collected each Monday. Trash should be placed curbside in supplied containers by 6:00 am (but not before 7:00 pm the day before).
	Yard Waste	Yard waste is also collected on Mondays. Please place yard waste curbside in brown paper yard waste bags (NO PLASTIC BAGS) or in a reusable container marked with an 'X'.
<b>Wednesday</b>	Bulk Trash	Bulk Trash is collected each Wednesday after 6am by appointment only. Call 301-773-2069 for an appointment before 2pm Tuesday. Bulk Trash should be placed curbside by 6:00 am (but not before 7:00 pm the day before).
<b>Friday</b>	Recyclables	Recyclable waste is also collected on Fridays. Please have recyclable waste curbside in the container provided by 6:00 am (but not before 7:00 pm the day before) – NO PLASTIC BAGS
