<b>Monday</b>	Household Trash	Regular Trash is collected each Monday. Trash should be placed curbside in supplied containers by 6:00 am (but not before 7:00 pm the day before).
	Yard Waste	Yard waste is also collected on Mondays. Please place yard waste curbside in brown paper yard waste bags (NO PLASTIC BAGS) or in a reusable container marked with an 'X'.
<b>Wednesday</b>	Bulk Trash	Bulk Trash is collected each Wednesday after 6am by appointment only. Call 301-773-2069 for an appointment before 2pm Tuesday. Bulk Trash should be placed curbside by 6:00 am (but not before 7:00 pm the day before).
<b>Friday</b>	Recyclables	Recyclable waste is also collected on Fridays. Please have recyclable waste curbside in the container provided by 6:00 am (but not before 7:00 pm the day before) – NO PLASTIC BAGS

Recyclables are collected on Fridays in Colmar Manor. Please place your recycling bins curbside with lids tight (not on sidewalk or in roadway). Break down boxes to allow for more recyclables in the bin. Open lids allow for trash to blow and litter our community. Also, plastic bags should not be placed in or alongside recycle bins as it will not be collected
