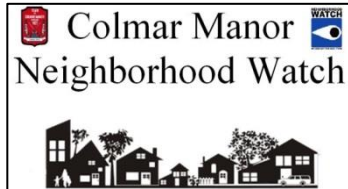
On 12/19/2021 at 12:09 PM a three vehicle accident was reported in the 3400blk of 37th Avenue. No injuries.

Code Enforcement:

	Yard Waste	Yard waste is also collected on Mondays. Please place yard waste curbside in brown paper yard waste bags (NO PLASTIC BAGS) or in a reusable container marked with an 'X'.
Wednesday	Bulk Trash	Bulk Trash is collected each Wednesday after 6am by appointment only. Call 301-773-2069 for an appointment before 2pm Tuesday. Bulk Trash should be placed curbside by 6:00 am (but not before 7:00 pm the day before).
Friday	Recyclables	Recyclable waste is also collected on Fridays. Please have recyclable waste curbside in the container provided by 6:00 am (but not before 7:00 pm the day before) – NO PLASTIC BAGS

There were 62 calls for service regarding traffic accidents in Colmar Manor in 2021 resulting in 28 traffic accident reports.

Colmar Manor officers made 156 traffic stops and issued 414 violations (citations, warnings, repair orders, etc).

There were 9 arrests during the year: 6 on-view arrests; 2 warrant services and 1 criminal citation.

There were 137 parking citations and 80 parking warning notices issued in Colmar Manor in 2021.
