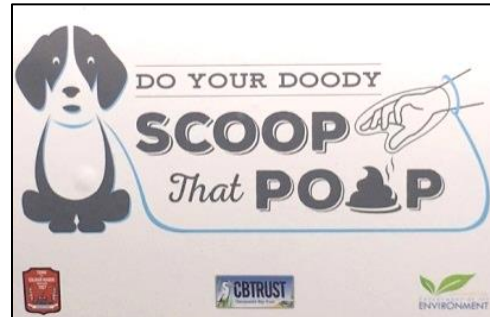
On 12/24/2022 at 3:43 pm a traffic accident was reported in the parking lot of Port Town Shopping Center. Minor damage.
